**ORDER PURSUANT TO BANKRUPTCY CODE  
SECTION 105(A) AUTHORIZING DEBTORS TO  
CHANGE CORPORATE NAMES AND MODIFY CASE CAPTION**

Upon the motion (the “*Motion*”)<sup>2</sup> of the Debtors for entry of an order in the above-captioned cases, for an order, pursuant to section 105(a) of title 11 of the United States Code (the “*Bankruptcy Code*”), approving the change of the Debtors’ names and caption of the Debtors’ chapter 11 cases; and it appearing that the relief requested is in the best interests of the Debtors’ estates, their creditors and other parties in interest; and the Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334; and consideration of the Motion and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b)(2); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and notice of the Motion having been adequate and appropriate under the circumstances; and after due deliberation and sufficient cause appearing therefore,

IT IS HEREBY ORDERED THAT:

1. The Motion is granted as set forth herein.

4. The name change of Chimerica Global Logistics LLC to Distributor CM LLC is hereby approved.

5. The name change of ArchBrook Laguna West LLC to Distributor West LLC is hereby approved.

6. The name change of Lehrhoff ABL LLC to Distributor LH LLC is hereby approved.

7. The name change of Expert Warehouse LLC to Distributor EW LLC is hereby approved.

8. The name change of ArchBrook Laguna New York LLC to Distributor NY I LLC is hereby approved.

9. The new caption of the Debtors' chapter 11 cases shall read as follows:
